# PR TREASURY ISSUES ADMINISTRATIVE DETERMINATION 15-02



## **Extension of the Due Date to File Supplementary Information**

As established by Administrative Determination 14-06 (issued on March 6, 2014), the due date to file the Supplementary Information (SI) required by Law 163-2013 will be the last day of the month following the extension due date of the income tax return (regardless of whether the entity filed an extension or not). Subsequently, the Puerto Rico Treasury Department issued other Administrative Determinations and Informative Bulletins regarding the further postponement of the SI filing.

On January 23, 2015, the PR Treasury issued Administrative Determination 15-02 (DA 15-02) to modify the due date to file the SI. For certain taxpayers, DA 15-02 extends the due date to file the SI from January 29, 2015 to **February 27, 2015**.
